On 10-31-22 Chelsie Walker was reported missing by family members after not returning home to her children, family or job. Upon investigation, it was discovered that Ms. Walker had left the Wal-Mart in Madisonville with Hayden Millsaps on 10-29-22. Ms. Walker's vehicle was discovered in the Wal-Mart parking lot in Madisonville abandoned. Upon viewing the security footage from Wal-Mart Ms. Walker was seen getting into a vehicle with Hayden Millsaps. Upon speaking with Hayden Millsaps he advised that he did pick Ms. Walker up at Wal-Mart and they both went to 830 Sawmill Road in Tellico Plains, which is the residence of Andrew Young. Mr. Young did advise that Ms. Walker and Mr. Millsaps came to this residence on 10-29-22. Ms. Walker has not been seen since this date. Upon checking Ms. Walkers ORNL bank card it was discovered that the card was used to purchase gas at the Gulf station on Highway 68 in Tellico Plains. Upon reviewing video footage from the gas station, Andrew Young was the person observed using the card. The amount of purchase was 30.00 and the purchased was made at 1:19 pm which is after the date that Ms. Walker had gone missing. Mr. did not have the affective consent to use Ms. Walker's Debit card to make the purchase. This occurred in Monroe County Tennessee.



On 11-03-22, **Conway Mason** and Detectives executed a search warrant at the residence of **Andrew Young**. Upon executing the search warrant we discovered a one pot meth lab located in a dryer inside the residence. The one pot contained a liquid, lithium strips, and lye. By combining these products he began the extraction of an immediate methamphetamine precursor from a commercial product, an began the active modification of a commercial product for use in methamphetamine creation.
